CCG Corporate Briefing

Locality Elections

Elections for Steering Group Members will be taking place in four of the five localities over 2017. Currently, both Burnley and Rossendale Localities have commenced their re-election process, with expressions of interest being sought for the various positions on their respective Steering Groups. This will include the election of the Locality Chair, who will hold a seat on the Governing Body.

All appointments will begin on 1st April 2017. You may recall that Dr Vanesa Warren took up the appointment of interim Chair for Ribblesdale from the beginning of September 2016. Ribblesdale will commence its reelection process in April, with the newly elected members taking up their roles from 1st June 2017. Hyndburn Locality will commence its re-election process in July, with newly elected members taking up their roles from 1st October 2017.

Discussions are ongoing regarding future development within the Localities and how wider collaboration and new ways of working could be taken forward.

Pennine Lancashire Transformation Programme

The Programme is currently developing its overarching business case (the Pennine Plan), which will be published for consultation in April 2017. The Pennine Plan will set out the Transformation Programme's response to the Pennine Lancashire Case for Change (published in summer 2016) and identified the key issues to be addressed to achieve the Triple Aim of improving population health outcomes, improving care and quality and achieving financial sustainability.

Alongside the development and publication of the Pennine Plan, detailed business cases are in development for each of the components: Living Happy, Healthy and Well; Keeping Happy, Health and Well; Joined-up Care and Support; and, In Hospital Care and Support. These will be supported by a suite of strategies covering finance, estates, digital and workforce. It is anticipated that these will be published for consultation and engagement in summer 2017. In line with the Pennine Lancashire governance arrangements, the development of these business cases and strategies will be overseen by the Pennine Lancashire System Leaders' Forum, and regular update reports, and draft documents, will also be submitted to organisational governing bodies for comments and approval prior to publication.

The Pennine Lancashire System Leader's Forum is working through an agreed process to develop proposals for how an Accountable Care System could be designed for Pennine Lancashire. This will include consideration of the proposals for the new models of care and discussions about which services are appropriate for inclusion in the design of an Accountable Care System.

Right Care

Based upon the latest financial plan, the CCG is required to deliver savings in 2017/18 of about £14m. This is a significant amount of money and work is underway to ensure that we deliver this. To oversee this, we have established the Sustainability and Performance Group whose members are primarily senior managers. The group is focused on utilising the 'NHS Right Care' approach to realising savings. Both East Lancs and Blackburn with Darwen CCGs are part of the NHS Right Care Wave 2 implementation group and have been assigned a 'Right Care' delivery partner from NHS England.

Our key priorities include:

- Asthma;
- Chronic Obstructive Pulmonary Disease (COPD);
- Musculo-skeletal (MSK) problems;
- Mental health;
- Cardiovascular disease (CVD), including atrial fibrillation, high blood pressure and hypertension.

Asset Based Community Development

Cormac Russell, Managing Director of Nurture Development and a member of the Asset Based Community Development (ABCD) Institute at Northwestern University, Chicago visited the CCG on 12th and 13th January 2017.

Cormac has influenced governmental recent thinking about the benefits of Asset Based Community Development, and was appointed to the Expert Reference Group on Community Organising and Communities First, by Nick Hurd MP, MP, Minister for Civil Society in the UK.

The visit included a number of informal discussions across the organisation, focusing on our current landscape and approach to ABCD, and how we can build on this. The CCG has already begun to adopt this approach in our investment in social prescribing, through the work of our integrated neighbourhood teams, and our investment in the third sector to improve access to psychological therapies. However the CCG is keen to explore and deepen our relationship with our communities through an asset based community approach.

Following the discussions, the CCG and Cormac will come up with a report and plan for consideration by members.

We are pleased to be able to confirm that following revised discussions with the landlord of Walshaw House, we have negotiated a revised lease and financial terms to enable the continuation of Walshaw House as the CCG headquarters until 2021.
